


State of the Jeffco Economy

Jefferson County's economic situation continued to improve, with continued employment gains, low unemployment, and robust consumer trends. Employment in the county increased 1.9 percent between the third quarters of 2015 and 2016, generating an additional 4,410 jobs. The Jefferson County unemployment rate fell to 2.5 percent in the fourth quarter of 2016, a decline of 0.5 percentage points from the prior year. Consumer confidence rose 8.7 percent in the Mountain Region between the third and fourth quarters of 2016.



Jefferson County-based **Lockheed Martin Space Systems** is looking to move 650 jobs from California to either Colorado and Florida.



Ball Aerospace & Technologies Corp.



Ball Corporation is expanding its aerospace operations in the City of Westminster. The planned expansion, with options for multiple phases, will begin this year with an approved \$50 million capital investment by the corporation.



State of the Jeffco Economy

Jefferson County employment increased 1.9 percent in the third quarter of 2016 compared with the prior year, representing an additional 4,410 jobs. The sector that reported the largest percentage increase was manufacturing, which rose 4.7 percent or about 850 jobs between the third quarters of 2015 and 2016.
